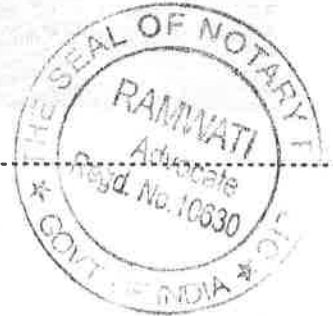


I, the above named deponent do hereby solemnly affirm and declare as under:




